3. **How To Enter the Contest**: Visit a Northwest Federal Credit Union branch during the Contest Period to open your first ever primary share account (which establishes a new membership) and deposit a minimum of \$50.00 at the time of opening.

**NO PURCHASE NECESSARY OPTION**: To enter without having to deposit a minimum of \$50.00 into a new membership account, existing or new members may visit one of the branches listed in section 2 and request a "no purchase necessary" entry card. The card must be completed by an eligible person as defined in section 5 and submitted within the Contest Period. Maximum of one entry per member.

Contest sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries. All entries become property of Northwest Federal Credit Union and none will be returned. Any questions regarding the number of entries submitted shall be determined by the contest sponsor in its sole discretion, and Northwest

- 4. **Contest Period**: The contest will begin at 12:00 a.m. EST on May 13, 2024, and will end at 11:59 p.m. EST on July 20, 2024 ("Contest Period"). Entries must be submitted in a designated ticket box during branch hours.
- 5. **Eligibility:** All participants must be 18 years of age or older at time of contest participation, must be a legal resident of one of the fifty states of the United States or the District of Columbia, and be members in good standing of Northwest Federal Credit Union (as determined by sponsor in its sole discretion). Employees of the Credit Union and members of their household are not eligible to register for the contest. Contest void where prohibited by law.
