

Certificate Disclosure

Rate Information: The dividend rate and Annual Percentage Yield (APY) are as stated on the Rate Schedule. The APY assumes dividends will remain on deposit until maturity. A withdrawal will reduce earnings.

Compounding and Crediting: Dividends are posted and compounded monthly. If you close your Certificate before dividends are credited, you will receive accrued dividends, unless they are part of the penalty amount.

Minimum Balance Requirements: The minimum balance required to open a Regular or IRA Certificate is \$1,000.

Balance Computation Method: Dividends are calculated using the daily balance method, which applies a daily periodic rate to the full amount of principal for each day.

Accrual of Dividends: Dividends will begin to accrue on the business day you deposit noncash items (e.g., checks).

Transaction Limitations: Withdrawals prior to maturity are subject to the early withdrawal penalties stated below.

Maturity: Your account will mature on the date provided when opening or renewing your Certificate.

Renewal Policies: Your Certificate account may, at the Credit Union's discretion, automatically renew at maturity. If renewed, a Certificate Maturity Notice will be sent at least twenty (20) calendar days prior to the maturity date. If there is no response to the notice, and the Certificate continues to be offered, the Certificate will automatically renew at the rate determined to be in effect on the maturity date and for the same term. You will have a grace period of ten (10) calendar days to withdraw the funds in the account without being charged an early withdrawal penalty. Dividends will be paid at the renewal dividend rate on withdrawals made during the ten (10) calendar day grace period. If your Certificate account is not renewed, the balance will be deposited to your share account.

Early Withdrawal Penalty: We will impose a penalty if you withdraw any of the principal before the maturity date. For a term of six (6) months or less, the penalty will be 90 days of dividends on the amount withdrawn. For a term greater than six (6) months and less than two (2) years, the penalty will be 180 days of dividends on the amount withdrawn. For a term equal to or greater than two (2) years the penalty will be 365 days of dividends on the amount withdrawn. This penalty applies whether or not the dividends have been earned. If a withdrawal reduces the balance below the required minimum, the account will be closed and the applicable penalty imposed.

Non-transferable: The ownership of this account cannot be transferred outside of the Credit Union. Joint owners can be removed and/or added with the written consent of all owners.

Exceptions to Early Withdrawal Penalties: At our option and as permitted by law, we may pay the account before maturity without imposing an early withdrawal penalty when: a) An account owner dies or is determined legally incompetent, or b) An IRA owner reaches age 59 ½ or is disabled.

McLean 30 Month Certificate Disclosure

Eligibility Criteria: Promo code required to open McLean 30 Month Certificate.

Rate Information: The McLean 30 Month Certificate has a dividend rate of 4.51% and an Annual Percentage Yield (APY) of 4.60%. The APY assumes dividends will remain on deposit until maturity. A withdrawal will reduce earnings. Promotional certificates are not eligible for a dividend rate bonus.

Compounding and Crediting: Dividends are posted and compounded monthly. If you close your McLean 30 Month Certificate before dividends are credited, you will receive the accrued dividends, unless they are part of the penalty amount.

Minimum Balance Requirements: The minimum balance required to open a McLean 30 Month Certificate is \$1,000.

Balance Computation Method: Dividends are calculated using the daily balance method, which applies a daily periodic rate to the full amount of principal for each day.

Accrual of Dividends: Dividends will begin to accrue on the business day you deposit noncash items (e.g., checks).

Transaction Limitations: Withdrawals prior to maturity are subject to the early withdrawal penalties stated below. Additional deposits are not permitted.

Maturity: Your account will mature on the date provided when opening or renewing your Certificate.

Renewal Policies: Your Certificate account may, at the Credit Union's discretion, automatically renew at maturity. If renewed, a Certificate Maturity Notice will be sent at least twenty (20) calendar days prior to the maturity date. If there is no response to the notice the Certificate will automatically renew for a term of twenty-four (24) months at the rate determined to be in effect on the maturity date. You will have a grace period of ten (10) calendar days to withdraw the funds in the account without being charged an early withdrawal penalty. Dividends will be paid at the renewal dividend rate on withdrawals made during the ten (10) calendar day grace period. If your Certificate account is not renewed, the balance will be deposited to your share account.

Early Withdrawal Penalty: We will impose a penalty if you withdraw any of the principal before the maturity date. For a Certificate with a term of 30 months the penalty will be 365 days of dividends on the amount withdrawn. This penalty applies whether or not the dividends have been earned. If a withdrawal reduces the balance below the required minimum, the account will be closed and the applicable penalty imposed.

Non-transferable: The ownership of this account cannot be transferred outside of the Credit Union. Joint owners can be removed and/or added with the written consent of all owners.

Exceptions to Early Withdrawal Penalties: At our option and as permitted by law, we may pay the account before maturity without imposing an early withdrawal penalty when: a) An account owner dies or is determined legally incompetent, or b) An IRA owner reaches age 59 ½ or is disabled.

Neighbor 11 Month Certificate Disclosure

Rate Information: The Neighbor 11 Month Certificate has a dividend rate of 4.65% and an Annual Percentage Yield (APY) of 4.75%. The APY assumes dividends will remain on deposit until maturity. A withdrawal will reduce earnings. Promotional certificates are not eligible for a dividend rate bonus.

Compounding and Crediting: Dividends are posted and compounded monthly. If you close your Neighbor 11 Month Certificate before dividends are credited, you will receive the accrued dividends, unless they are part of the penalty amount.

Minimum Balance Requirements: The minimum balance required to open a Neighbor 11 Month Certificate is \$1,000.

Balance Computation Method: Dividends are calculated using the daily balance method, which applies a daily periodic rate to the full amount of principal for each day.

Accrual of Dividends: Dividends will begin to accrue on the business day you deposit noncash items (e.g., checks).

Transaction Limitations: Withdrawals prior to maturity are subject to the early withdrawal penalties stated below. Additional deposits are not permitted.

Maturity: Your account will mature on the date provided when opening or renewing your Certificate.

Rate Information: The Dealer 11 Month Certificate has a dividend rate of 4.65% and an Annual Percentage Yield (APY) of 4.75%. The APY assumes dividends will remain on deposit until maturity. A withdrawal will reduce earnings. Promotional certificates are not eligible for a dividend rate bonus.

Compounding and Crediting: Dividends are posted and compounded monthly. If you close your Dealer 11 Month Certificate before dividends are credited, you will receive the accrued dividends, unless they are part of the penalty amount.

Minimum Balance Requirements: The minimum balance required to open a Dealer 11 Month Certificate is \$1,000.

Balance Computation Method: Dividends are calculated using the daily balance method, which applies a daily periodic rate to the full amount of principal for each day.

Accrual of Dividends: Dividends will begin to accrue on the business day you deposit noncash items (e.g., checks).

Premier 10 Month Certificate Disclosure

Rate Information: When opened in-person at an NWFCU branch, the Premier10 Month Certificate has a dividend rate of 4.75% and an Annual Percentage Yield (APY) of 4.85%. When opened online or over the phone, the Premier 10 Month Certificate has a dividend rate of 4.65% and an APY of 4.75%. The APY assumes dividends will remain on deposit until maturity. A withdrawal will reduce earnings. New money only; Premier 10 Month Certificate must be funded with money not currently on deposit at Northwest Federal. Promotional certificates are not eligible for a dividend rate bonus.

Compounding and Crediting: Dividends are posted and compounded monthly. If you close your Premier 10 Month Certificate before dividends are credited, you will receive the accrued dividends, unless they are part of the penalty amount.

Minimum Balance Requirements: The minimum balance required to open a Premier 10 Month Certificate is \$100,000.

Balance Computation Method: Dividends are calculated using the daily balance method, which applies a daily periodic rate to the full amount of principal for each day.

Accrual of Dividends: Dividends will begin to accrue on the business day you deposit noncash items (e.g., checks).

Transaction Limitations: Withdrawals prior to maturity are subject to the early withdrawal penalties stated below. Additional deposits are not permitted.

Maturity: Your account will mature on the date provided when opening or renewing your Certificate.
